

**MEMORANDUM OF UNDERSTANDING
BETWEEN
YOGYAKARTA STATE UNIVERSITY, INDONESIA
AND
YALA RAJABHAT UNIVERSITY, THAILAND**

This Memorandum of Understanding (hereinafter referred to as MoU) is made on thisday of 2015 by and between Yogyakarta State University, Indonesia and Yala Rajabhat University, Thailand. Both universities have agreed to cooperate based on mutual trust and benefit for purpose of developing two universities and promoting international exchange and cooperation.

ARTICLE 1

Objective

The objective of this MOU is to develop and promote ties between both universities and to promote academic exchange between the two countries.

ARTICLE 2

Scope of Cooperation

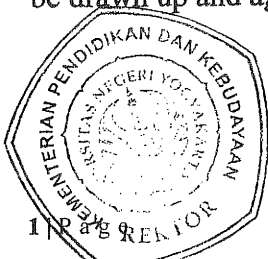
Both Yogyakarta State University and Yala Rajabhat University agree to do the following cooperation:

1. Exchanges of faculty and administrative staff;
2. Exchanges of students;
3. Exchanges of research materials, publications, and other academic information;
4. Facilitation of in-country world experience for students in relevant fields of studies;
5. Joint research projects;
6. Any other academic activities beneficial for both universities.

ARTICLE 3

Plan of Action

A detailed description of every cooperation will be defined in separate documents, which shall be drawn up and agreed upon by Yogyakarta State University and Yala Rajabhat University.



ARTICLE 4

Financial Arrangement

The Parties understand that all financial arrangements will have to be negotiated and will depend on the availability of funds, and agreed upon mutually in writing between Parties.

ARTICLE 5

Duration and Termination

1. This agreement will come into effect when signed by the representatives of both institutions and will have duration of five (5) years.
2. Extensions and/or modifications may be made as agreed in writing by both parties.
3. Each party may cancel this agreement by providing the other with a written notice six (6) months prior to the date of cancelation.

ARTICLE 6



